Central AC Rebates Eligibility:

Units with a **SEER** (Seasonal Energy Efficiency Ratio) of **14** or greater that are listed as Residential Energy Star (current) at www.ceehvacdirectory.org/ac.php.

Additional Central Air Conditioner Requirements:

1. Installer/Homeowner must verify that both Condenser SEER and Evaporator SEER meet the eligibility standards found at: www.ceehvacdirectory.org/ac.php.
2. Provide both condensing unit and evaporator unit model numbers on rebate form.
3. Only those units listed under Tier 1, Tier 2 or Residential Energy Star (current) are eligible for a rebate. (Use web address above.)
4. Attach receipts to rebate form. Receipt must show the equipment installed.
5. Eligible equipment must be presently listed as Energy Star compliant.
